**IT IS ORDERED** that:

1. The First, Second, Third, Fourth and Fifth Respondents must not until the conclusion of the trial of this action or until further order in the meantime enter the premises listed in Schedule 1 at any time and for any purpose without the express written permission of the Applicant referred to in the 'Control' column of the Schedule.
2. The Sixth Respondent must not until the conclusion of the trial of this action or until further order in the meantime enter the premises listed in Schedule 1 and located in England or Wales at any time and for any purpose without the express written permission of the Applicant referred to in the 'Control' column of the Schedule.
3. The First, Second and Third Respondents must to the best of their ability within 7 days of service of this order on them send the Applicants' solicitors in writing the names, addresses and any other contact details (including social media details) of any other individuals with whom the Respondents or any of them have climbed and/or entered the premises listed in Schedule 1 without permission.
4. This Order shall be served by 4pm on 1 June 2018 as follows:
  - a. On the First, Second and Third Respondents, by first class post or by sending it by e-mail to the applicable addresses listed at Schedule 3 to this Order.
  - b. On the Fourth Respondents by serving two additional copies of the Order on any of the First, Second or Third Respondents at the same time, marked for the attention of "*persons unknown who entered LEGOLAND Windsor Resort with Alistair Law, Rikke Brewer and/or Scott Mackay on 26 April 2018*".
  - c. On the Fifth Respondent by serving an additional copy of the Order on any of the First, Second or Third Respondents at the

same time, marked for the attention of "*person unknown who entered Alton Towers Resort with Alistair Law, Rikke Brewer and/or Scott Mackay on 5 May 2018*".

- d. The copies of the Order to be served in accordance with paragraphs 4.a. – 4.c. above must be accompanied by the Applicants' note of the judgment given at the hearing on 25 May 2018.
- e. On the Sixth Respondents by:
  - i. affixing at each of the premises listed in Schedule 1 a notice that an injunction has been granted preventing certain individuals from entering the premises, accompanied by a transparent envelope containing copies of this Order; and
  - ii. the prominent display on the website <http://www.merlinentertainments.biz/> (or on each attractions' website) of a notice stating that an injunction has been granted preventing certain individuals from entering the premises, with a link to a page where a copy of this Order may be viewed.

#### **SERVICE OF THE PROCEEDINGS**

- 5. Service of the Claim Form, Particulars of Claim and the Applicant's application for an injunction upon the Fourth and Fifth Respondents shall be deemed to have occurred at the same time as service on any of the First, Second or Third Respondents.
- 6. Service of the Claim Form, Particulars of Claim and the Applicant's application for an injunction on the Sixth Respondents is dispensed with.
- 7. The Applicants have permission to amend the Particulars of Claim in the form lodged at Court on 23 May 2018. Service of the Amended Particulars of Claim is dispensed with.

#### **OTHER MATTERS**

8. The First, Second and Third Respondents must jointly and severally pay the Applicants' costs of this application by 8 June 2018, summarily assessed in the sum of £41,364.73.
9. It is a contempt of court for any person notified of this order to knowingly assist in or permit a breach of this order. Any person doing so may be imprisoned, fined or have their assets seized.
10. A Respondent who is an individual who is ordered not to do something must not do it himself or in any other way. He must not do it through others acting on his behalf or on his instruction or with his encouragement.
11. The Fourth and Fifth Respondents will be at liberty to apply to set aside or vary this order so far as it concerns them. Any application to set aside or vary this order must be made within 14 days of service of the order on that Respondent. Any person making such an application must give the Applicant's solicitors 48 hours' written notice of the application using the address and reference given at the foot of the order.
12. Anyone falling within the description of the Sixth Respondent on the first page of this order will be at liberty to apply to set aside or vary this order so far as it concerns them. Any application to set aside or vary this order must be made within 14 days of service of the order coming to their attention. Any person making such an application must give the Applicant's solicitors 48 hours' written notice of the application using the address and reference given at the foot of the order.

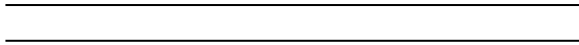
